Dear Parent/Guardian,

2nd Dose - COVID-19 vaccination for 12-15 year olds

Actions:

1. **After reading the letter, and accompanying information, discuss with your child the benefits and risks of the COVID-19 vaccination**
2. **Complete consent form (2 pages), including NHS Number**
3. **Sign and date the consent form**
4. **Return completed consent form to the school at least 48 hours before vaccination session**
5. **Notify the school of any changes to child's health before the session**

Following the recommendation by the Government, the School-aged immunisation team will be visiting all secondary schools in Portsmouth, Southampton, and on the Isle of Wight from January 2022 to offer all students in years 8-11 a 2nd dose of COVID-19 vaccine. No vaccines will be administered without valid consent (see consent section for further details).

We plan to visit your child's school on **Friday 21st January 2022**.

Anyone aged 12 to 15 years old is eligible to receive the Pfizer vaccine. This includes –

- **children aged 12-15 who have not yet had a first dose of COVID Vaccine,**
- **pupils in Year 7, who have reached their 12th birthday on the day of the session**
- **children who have had a positive PCR test and are at least 12 weeks past this date**

Your support helps us protect the health of all the children within your school and the wider community.

Consent process

All parents, or those with parental responsibility, are asked to provide consent and we encourage you to make this decision together with your child/children, and by completing the attached consent form.

In secondary schools, where a consent form has not been completed but the child is mature enough to make the decision to consent, they will be able to do so. We will enable this to happen by inviting the young person to a subsequent planned session. This may be held either at the school if appropriate, or in another vaccination setting and will allow the young person to have a further conversation with the healthcare team and someone with parental responsibility.

The attached paper consent form will need to be completed at least 48 hours in advance of your child's vaccination session to allow time for the clinical nursing team to triage and ensure that your child can receive the vaccination safely. If you do not wish for your child to be vaccinated, a non-consent can also be provided on the same form. **Please ensure you complete all sections of the form** including NHS Number – the link below can help you find this.

If your child is unwell, or there is a change in their health status including any new health diagnosis or new medication, please notify your child's school on the day of the session.

Please return the consent form back to your school by **Wednesday 19th January 2022**.

****Please note that if a form is incomplete, we may be unable to give the vaccine at this session. Both sides of the form need to be completed, including the health questions, and the form must be signed and dated.**

Parent information pack

About the Covid-19 Vaccine

All children aged 12-15 will now be offered a 2nd dose of the Pfizer/ BioNTech Covid-19 vaccine. If your child has not received a 1st dose this too is offered.

The COVID-19 vaccination will reduce the chance of your child suffering from COVID-19 disease. It may take a few weeks for their body to build up some protection from the vaccine.

Like all medicines, no vaccine is completely effective – some people may still get COVID-19 despite having vaccinations, but this should be less severe. Further information is available on symptoms on NHS.UK.

The vaccines do not contain organisms that grow in the body, and so are safe for children and young people with disorders of the immune system. These people may not respond so well to the vaccine, but it should offer them protection against severe disease.

Side effects

Like all medicines, vaccines can cause side effects. Most of these are mild and short-lived, and not everyone gets them. With the vaccine we use in under-18s, side effects are more common with a second dose.

Very common side effects include:

- painful, heavy feeling and tenderness in the arm at injection site
- feeling tired
- headache
- general aches, or mild flu like symptoms.

The above can be safely managed by plenty of fluids, home remedies such as Paracetamol and/or Ibuprofen (following the dosing instructions) and moving the arm. They usually resolve within 24-48 hours.

Less common side effects:

Following administration of Pfizer vaccine to protect against Covid 19 there have been very rare reports of the following side effects, these have usually occurred a few days after a second dose:

- Shortness of breath
- Chest pain
- Feelings of having a fast beating or pounding heart

Most symptoms are short-lived and will resolve spontaneously with some rest and simple treatments. However, should your son/daughter experience any of these symptoms, and you are concerned, please contact your GP or NHS 111 and explain that he/she has recently been vaccinated with Pfizer vaccine. Where can I find information on COVID-19 vaccination for children and adults?

When do the vaccinations need to be given?

The 2nd dose (or 1st if not received) of COVID-19 vaccinations for children aged 12-15 will commence from January 2022 and will run across all secondary schools for around 6- 8 weeks. You will be provided with the date of your child's planned school session in advance and you will be asked to complete a consent form.

It is important to note that this academic year the school age immunisation team will also be offering the nasal flu vaccine to all students in years 7-11 to help reduce the incidence and transmission of flu. Following national approval where consent has been received for both nasal flu and Covid-19 vaccine, these may be administered at the same session. Who will be giving the vaccine to the children?

The programme will be delivered by an NHS commissioned School-aged Immunisation team (SAI) which will include nurses, healthcare support workers, administrative staff, and other associated professionals who specialise in the delivery of school age vaccinations and COVID-19 vaccinations. The team will administer the vaccination according to nationally agreed standards. Staff are appropriately qualified, trained (including in safeguarding) and experienced in vaccinating children and young people. Staff administering the vaccine will be wearing appropriate personal protective equipment and your child will be asked to wear a face covering during the vaccination

How will the SAIS provider team identify the children to be vaccinated?

The consent form will be either emailed to parents and carers of all eligible students via your school or sent home with your child for you to complete for each individual child who is eligible for vaccination. The form will need to be completed at least 48 hours in advance of your child's school session to allow time for the clinical nursing team to triage and ensure that your child can receive the vaccination safely. If you do not wish for your child to be vaccinated, non-consent can also be provided on the same form

The team will then have a list of all children for whom consent has been received in advance of the immunisation session.

What about those children turning 12 years of age within the school year, after the date of the vaccination session?

We will offer a vaccination to all children aged 12 years and over on the day of the school visit .

We will also offer this to the following groups too -This will help to ensure that the following pupils can access the vaccine:

- those turning 12 years after the session
- those who were absent from school on the day of the 1st session
- those who have had a COVID-19 infection over 12 weeks ago
- those who subsequently change their minds, or take longer to reach a decision

Where relevant, please do not contact your GP surgery – unless your child is considered to be clinically extremely vulnerable (CEV) and has not already been offered a Covid vaccination

Handy tips for preparing your son/daughter for COVID-19 vaccination

- Ensure your son/daughter tells us on the day if he/she has had a confirmed positive PCR test since you provided your consent or 12 weeks or less before the planned vaccination.
- Encourage them to have breakfast and drink regularly throughout the school day.
- Ask him/her to wear short-sleeved and loose-fitting shirt to allow us to be able to get to the top of his/her arm. The injection is usually given in the arm they do not write with.
- If he/she is known to suffer with severe needle phobia, or prone to fainting please speak to school as we can arrange for your child to be vaccinated earlier in the day.
- Help them with strategies for staying calm during the vaccination – it's natural to worry but we want your son/daughter's arm to be as relaxed as possible.
- Let your child know what's going to happen in simple language – for example, "you may feel a sharp scratch that will go away very fast".

In addition to the scheduled school programme, we are now able to offer sessions at our large vaccination centres in Portsmouth, Southampton, and Isle of Wight on dedicated days. These sessions will be available for anyone to book into via the national booking system.

Appointments are available at weekends and after school to ensure education is not disrupted. Anyone aged 12-15, who has not already accessed a vaccination is eligible to book including those who were unable to make the scheduled school session; for young people who are home schooled and or anyone whom may have changed their mind since their first vaccination offer. The sessions will have limited capacity available and you will be required to make an appointment before attending.

If you would like your child to attend one of the sessions these are the required actions:

1. Book an appointment on the national booking system for your child
2. Complete the consent form attached and bring with you to the session; we encourage you to make this decision together with your child/children where possible
3. Please ensure your child's NHS number is completed on the form <https://www.nhs.uk/nhs-services/online-services/find-nhs-number/>
4. Please write your child's school name or identify that they are home schooled at the top of the consent form
5. A reminder that if your child has had COVID they will not be able to access a vaccination for 12 weeks after their confirmed status – this is a change to the previous 4 week guidance.
6. Please ensure that your child attends the session either with yourself or somebody with parental responsibility.
7. In order to make the vaccination process easier for your child please ensure they have eaten before they come along, that they bring a drink with them and if possible that they are wearing short sleeved clothing
8. Please bring with you your child's completed consent form
